Wedding Photo Contract

The undersigned (hereafter referred to as the client) agrees to contract the services of:

Armando Musquez Photography (at the above address)

Or designee according to the following terms:

The Client contracts for the services of *Armando Musquez Photography* for the Special Event scheduled on the date and times specified below. *Armando Musquez Photography* agrees to furnish all photographs and/or services as specified within two weeks after the special event date and to make available to the client extra prints for purchase.

Prices for extra prints are set according to *Armando Musquez Photography's* price list and are not included in this contract.

Armando Musquez Photography agrees to keep all digital photographs from this assignment for a period of one (1) year following the special event date.

It is the client's responsibility to provide the following:

1. **First and foremost is to ensure that the presiding clergy allows photos with flash during the ceremony.**
2. Designate a "Photo Coordinator" who will be in charge of crowd control, setting up photos and to ensure all parties involved are at designated areas for photo ops required or desired.
3. Ensure adequate space is available for the desired portraits photos, which also includes unobstructed space for camera lighting and available electricity.

The client hereby understands that *Armando Musquez Photography* retains all rights to the photographs for this special event for resell, publication or advertising.

A 50% deposit is required to lock the date. Balance is due, **in full**, two weeks prior to event date. In the event *Armando Musquez Photography* fails to provide the services described in this contract, liability to the Client is limited to a refund for the amount paid by the client with no consideration for additional fees or expenses incurred. In case the special event is canceled or postponed from the date scheduled at no fault to *Armando Musquez Photography* and less than 24 hours, barring any act of God, the deposits paid are non-refundable and a new contract will be required.

Out of area clients (outside Bee County) will be required to pay a travel fee and hotel accommodations if an overnight stay is required. Travel is calculated at \$1.00 per mile one way. Mileage is calculated using www.mapquest.com from address at **311 West Bowie St. Beeville, Texas 78102** to Client's event address.
